**NOTICE OF RATE CHANGE FOR SERVICES ON AZIMUT, DOCUMENTATION JURIDIQUE**

Dear Client,

The Société québécoise d'information juridique (SOQUIJ) would like to inform you of a rate change for services on AZIMUT, Documentation juridique, in application of clause 8 of the User Licence. **These changes will come into effect on January 1, 2011.**

Since its launch in 1999, AZIMUT has been constantly expanding.

In March 2010, the number of documents available through our Juris.doc service reached the one million mark. We have also been adding innovative features, including a spell checker to automatically detect errors in search terms, much to the satisfaction of our users.

We have also continued developing our Plumitifs service, applying recent technological advances to make it easier to use. New municipal courts have been added to our databases, which now cover over 80% of the Quebec territory.

All of these improvements are the result of our team's daily efforts to deliver you the products you need and the high-quality online service you expect.
