NOTICE OF RATE CHANGE FOR SOQUIJ ONLINE SERVICES

Dear Client,

SOQUIJ will be making changes to its rates for online services, pursuant to clause 8 of the User License. **These changes will come into effect on January 1, 2016.**

Over the last year, you have been invited to migrate to the new **Recherche juridique** service in the **Portail SOQUIJ**. This service's single \$5.55 flat rate includes the summary, full text, Historique, and Citateur for each judgment consulted, making access to quality legal information more affordable than ever before. The \$5.55 flat rate now applies when you consult judgments through the Collections and Plumitifs services as well.

Recherche juridique was built from scratch by our computer analysts and technicians, and we will continue to make improvements to the service to meet your needs as best we can.

In the spring of 2015, a new Quebec *Code of Civil Procedure* with the commentary of the Minister of Justice was made available through the Portail SOQUIJ *Collections* service. This publication, prepared at the request of the Ministère de la Justice in collaboration with publishers Wilson & Lafleur, provides assistance to users of the new *Code*. Improvements have also been made to the *Plumitifs* service, with more to come over the next year, ensuring that SOQUIJ continues to play a prominent role on the Quebec legal landscape.

Marrying legal knowledge and technical expertise, SOQUIJ provides the tools and services needed to enhance accessibility to quality legal information. Thanks to the loyalty of our clients, we can continue to do so.
