NOTICE OF RATE CHANGE – AZIMUT, DOCUMENTATION JURIDIQUE

Dear Client,

This letter is to inform you that the *Société québécoise d'information juridique* (SOQUIJ) is making changes to the rates for services on *AZIMUT, Documentation juridique*, in accordance with Section 8 of the User's License. The changes will come into effect on **January 1, 2009**.

AZIMUT has been in constant development since its inception in 1999. This year, SOQUIJ has classified appellate judgments rendered since January 1, 2006 in other Canadian provinces and territories, and incorporated them into the AZIMUT data banks.

SOQUIJ has also expanded its scholarly commentary data bank, now providing access to articles from five different university law journals, at no extra cost.

We have also made *Juris.doc* searches easier by introducing *Recherche Multibanques*, our multi-bank search tool. Now you can cover every angle in your research in one simple step.

These improvements are the result of our team's daily efforts to provide high-quality products and services that meet your expectations.
