NOTICE OF RATE CHANGES FOR AZIMUT, DOCUMENTATION JURIDIQUE SERVICES

Dear Client,

The Société québécoise d'information juridique (SOQUIJ) would like to inform you of rate changes for the services available through AZIMUT, Documentation juridique, in application of clause 8 of the User Licence. **These changes will come into effect on January 1, 2013.**

Once again, SOQUIJ has spent the year improving its content and services. The new **Collections** service now includes three publications: the annotated *Civil Code of Québec (Code civil du Québec annoté Baudouin Renaud)*, the annotated *Code of Civil Procedure (Alter Ego – Code de Procédure civile du Québec)*, and the information access and privacy protection guide (*Guide pratique sur l'accès et la protection de l'information*) published in collaboration with the AAPI. The decisions of the Tax Court of Canada are now available through **Juris.doc**, and the commentary databank (*Banque Doctrine*) now contains the *Revue juridique des étudiants et étudiantes de l'Université Laval*.

SOQUIJ also continues to refine Plumitifs. Recent technological improvements have made it easier to use, and new municipal courts are added regularly to the service, which now covers **nearly 85%** of the territory of Quebec.
