NOTICE OF RATE CHANGE FOR *AZIMUT, DOCUMENTATION JURIDIQUE SERVICES*

Dear Client,

The Société québécoise d'information juridique (SOQUIJ) would like to inform you of a rate change for services available through AZIMUT, Documentation juridique, in application of clause 8 of the User Licence. **These changes will come into effect on January 1, 2012.**

Once again, SOQUIJ has spent the year working to improve its content and services. In 2011, the major features that have seen the light of day are AZIMUT password retrieval, the inclusion of *Revue du Barreau* articles in the Banque Doctrine, and the addition of 30,000 hyperlinks to the *Civil Code of Québec* and the *Act respecting the implementation of the reform of the Civil Code*.

SOQUIJ also continues to refine Plumitifs. Recent technological improvements have made it easier to use, and new municipal courts have also been added to the service, which now covers over 80% of the territory of Quebec.

These advances are the result of the daily efforts made by our team with the goal of offering you high-quality online products and services that meet your expectations.

All our teams are currently hard at work on the new legal research platform upgrade, which is slated to launch in late 2012.
