NOTICE OF RATE CHANGES FOR SOQUIJ'S ONLINE SERVICES

Dear client.

SOQUIJ would like to inform you of rate changes for its online services, pursuant to clause 8 of the User Licence. **These changes will come into effect on January 1, 2015.**

Over the last few months, we have been slowly rolling out our **new SOQUIJ Portal** to selected clients. The interface for navigating between the different services has been completed and includes a centralized Office for users to manage their profile settings and service preferences.

The Portal also features the new **Recherche juridique** service, which aims to improve the experience of users searching for case law, commentary and legislation. This is a major project, and we will be sending you more information about it soon. We can already tell you, however, that a simplified fee of \$5.55 will be charged for every decision consulted, which will provide access to the summary, full text, case history and noting-up record (Le Citateur).

SOQUIJ will also continue to develop its Plumitifs, Express and Collections services. Our Collections include the recent update of the *Guide pratique de l'AAPI* and the *Loi sur la protection de la jeunesse annotée*. The Plumitifs, cours municipales service has also been enhanced with the addition of the court registries of the cities of Québec, East Angus and Sept-Iles.

With the launch of the new SOQUIJ Portal, 2015 will be a year of innovation, when legal information will become even more accessible to everyone.
